

About the Council

Membership

The membership of the Hong Kong Subsidized Secondary Schools Council HKSSSC (hereinafter referred to as "the Council") is open to all subsidized secondary schools in Hong Kong. In 2008-2009 school year, 348 subsidized secondary schools represented by principals or acting principals have registered as member schools of the Council on payment of an annual subscription as approved by the Executive Committee, representing 70% of all about 500 secondary schools of various types (including government schools, grant schools, direct subsidy and private schools, etc.) in the territory.

Status

The Council is an association of subsidized secondary schools registered under the Societies Ordinance of the HKSAR Government as a non-profit making professional body. As its membership comprises all subsidized secondary schools, the Council is the largest and the most influential educational organization in the local secondary education sector. In this context, the Council often plays a major consultative role on educational issues in the education authority as well as in various statutory educational organizations in Hong Kong. Apart from holding membership on numerous advisory committees under the government, the Council also holds ex-officio membership in the Court of the University of Hong Kong.

Objects

The objects of HKSSSC are as follows:

- To provide and advance the cause of Education in Hong Kong.
- To promote and protect the rights and independence of all subsidized secondary schools in Hong Kong (hereinafter referred to as "the member schools")
- To promote and enhance the welfare and interest of the staff and students in the member schools.
- To provide a representative body for all member schools.
- To act as a liaison for member schools with the government and other bodies.
- To assert the Council's corporate opinions on education policies and to render services in respect thereof when necessary.

Executive Committee

The Executive Committee consists of 14 members: the immediate past chairman is an ex-officio while the Chairman, Vice-Chairman, Hon. Secretary, two Assistant Hon. Secretaries, Hon. Treasurer and seven Area Representatives are elected from amongst the principals of all registered member schools at the Annual General Meeting on the basis of one-school-one vote. The term of office of all Executive Committee members is two years. Three additional members may be co-opted by the Executive Committee for a term of two years.

簡介

會員數目

香港津貼中學議會（簡稱為“議會”）的成員是來自全港的津貼中學。2008 - 2009年度，共有348所由校長或署任校長作為代表的津貼中學繳付年費成為本會會員，約佔全港500所各類型中學（包括官立、補助、直資及私立等中學在內）的百分之七十。

地位

本議會為一津貼中學聯校組織，已依香港特別行政區政府社團條例註冊為一個非牟利的教育專業團體。由於本議會會員涵括全港的津貼中學，故為本地中學教育界最大且具影響力的教育團體，香港教育當局及其他法定教育組織均會向本議會諮詢教育問題。此外，本議會不但在政府眾多的教育諮詢委員會中佔有席位，而且也是香港大學校董會的當然成員。

宗旨

本議會成立的宗旨如下：

- 建立和提升香港教育的理想目標。
- 促進及維護全港津貼中學（簡稱為“議會成員”）的權利和獨立自主。
- 促進和爭取增加議會成員教職員工及學生的福利和權益。
- 成為全港議會成員的代表團體。
- 擔任議會成員與政府及其他機構之間的聯絡和中介角色。
- 維護本議會對本港教育政策的意見，並在有需要時提供協助或服務。

執行委員會

由十四位委員組成，除前任主席為當然委員外，主席、副主席、義務秘書、兩名助理義務秘書、義務司庫及七位地區代表共十三名委員，均在週年會員大會中由出席校長以一票一票選任，任期二年；另執行委員會可增補三名校長成為增補執行委員，任期亦為二年。
